### 1. Aim and Purpose

Ensuring that, in accordance with animal disease legislation and the requirements of the QSGF concept, it is clear which prohibited and critical substances are involved, which are prohibited or critical for transport, as well as assistance in determining suitable cleaning measures.

Loose transport (solids and liquids)

### 4. Description

#### 4.1. Prohibited substances (see also list TP 6.11)

In the event of such summonses, feed, grain and foodstuffs may no longer be transported:

- Slaughterhouse waste / animal by-products category 1 and 2 (are whole carcasses, parts of carcasses or products of a slaughtered animal that are not directly used for human consumption)
- Wet products such as offal, feathers, bone parts, hair, rinds
- Meat-and-bone meal of all animal species/ meat bone meal, meal
- Blood meal or products containing blood
- Gelatine from ruminant waste and products containing gelatine
- Greaves flour / greaves cake
- Radioactive substances (radionuclides, fuel rods)
- Asbestos, substances containing asbestos (Asbestos is a collective term for naturally occurring fibrous mineral silicate materials. It is formed by the solidification of molten rock lava. Asbestos has long been a component of building materials because it has a high electrical and thermal insulating capacity. Asbestos is a carcinogenic substance. Asbestos fibres, which enter the lungs through the air we breathe, are particularly harmful.)

#### 4.2 Critical subpoenas / critical substances (see also list TP 6.11)

If such products have been in the last 3 summonses, according to TP 6.11, a specific professional cleaning is required, which is based on the Form 490 or an equivalent document.

- Garden / potting soil mixed with animal manure (peat mixtures, bark substrates, green composts)
- metallic waste and lathe shavings (contaminated with oil, wet cleaning with detergent)
- Scrap and metal parts (dry cleaning, with the exception of moving floors and products containing mineral oil)
- Toxic, oxidized substances and packaging consisting of them
- Mineral clay used for detoxification
- Unpackaged seeds that have been treated with toxic substances (seed dressing)
- conventional products as a pre-loading of organic products
- Sewage sludge
- Household waste
- Untreated food residues (dirty water)
- GMO-declared substances (maize, soybean, rapeseed, cotton, rice) if they come from abroad or are included in the GMO feed list.
- Glass and glass splinters
- Organic and mineral fertilizers, salt
- Natural sawmill cleanbread products; reclaimed wood; Wood pellets; Paper, Cardboard
- Nanoparticles

#### 4.3 **Animal by-products of category 3 (e.g. Fishmeal) and products containing them**

For loose loads, wet cleaning. In the case of bagged goods, dry cleaning (with the exception of broken containers or product residues on the pallets, then wet cleaning)

Animal by-products must not come into contact with feed and must be physically separated

If animal by-products leak out of defective or unsuitable packaging, wet cleaning must follow. Cleaning must be documented. In the case of dry cleaning, the cleaning utensils must be cleaned wet or disposed of after use. Cleaning must be carried out directly at the loading/unloading location.

When handling open animal by-products and products containing them, as well as cleaning work, clothing and shoes must be changed after completion, and hands must be washed thoroughly.

Alternatively, shoe covers, gloves and disposable overalls can be worn.

These requirements must be complied with in any case!  
The product lists do not claim to be exhaustive. Additional information in TP 6.10
